A Member's Story:

When I came into AA for the first time, I asked my current sponsor if he would sponsor me. What he had asked of me was, "Are you willing to go to any length to stay sober?" and for the first time in my life I could honestly say yes. It turns out that a lot of those lengths are in service. It was suggested of me to start with a coffee commitment at my home group; it was new to do and felt strange, but frankly everything did especially early in my sobriety. From there, I have just been taking suggestions from both my sponsor, others, and sometimes just raising my hand or standing for a position when it felt right.

I have served in several different positions from helping on the Technology Committee for the North Florida Area, being a chairperson of my first homegroup's Beginner's Meeting, and most importantly saying yes when an alcoholic asks if I'd be willing to sponsor them. However, one of the positions that I most remember was my first Gratitude Dinner, when I was about three months sober. I helped make coffee and serve other alcoholics. What was most impactful was when one of the coffee makers malfunctioned and we didn't have de-caf coffee available to serve. I found out that some AA members felt it important to give me grief about the lack of coffee they wanted, which I quickly gained resentment toward them (an easy start to a 4th a step). But the members of AA that had helped me from the beginning and were among those that served at the event gave me an ear to listen and advice that helped me realize that I was doing my best, even though it didn't feel like enough. And that I am not responsible for making everyone happy. I am responsible for doing the next right thing and being there for the next sick and suffering alcoholic.

I was told to continue to take suggestions from those who had what I wanted. And those that have what I want and need in my life (peace and serenity), are the ones that continue to do service no matter how many days of sobriety they have behind them. To me, service doesn't mean being perfect or playing every role in the show. It's giving my time and energy toward the AA program that gave me a new way and joy for life and passing on a message of recovery to those who are willing to listen.
